

Items We Provide on the Units

- > Blankets, pillows, sheets, towels and washcloths
- > Deodorant
- > Lotion
- > Shampoo/Conditioner
- > Toothpaste and toothbrushes
- > Hair brushes and combs
- > Lip Balm
- > Ear Plugs

Approved Items for Clients to Have/Receive on the Units

- > T-shirts and sweatshirts. Shirts with foul language or inappropriate images will not be permitted.
- > Jeans without holes.
- > Sweatpants/appropriate length shorts WITHOUT strings.
- > Pajama tops and bottoms WITHOUT strings.
- > Shoes with laces removed, slip-on shoes/sandals.
- > Younger adolescents are permitted to have ONE personal item upon admission such as a pillow, stuffed animal, blanket, etc. They can obtain more items as they level up through their program.
- > Coloring books and sketch pads are permitted for all ages and units as long as they do not have a spiral back. Colored pencils, crayons, and markers are provided by rec therapy.
- > Personal colored pencils, markers, or crayons must be pre-approved by a therapist or doctor before the client can receive them on the unit.
- > Topical creams/medications/lotions must be pre-approved by a doctor before the client can receive them on the unit.
- > Special detergents, deodorants, and soaps MUST be pre-approved by a doctor before the client can receive them on the unit.
- > Each client can have up to three days' worth of clothing at any given time (e.g., three pairs of pajama pants, three pajama tops, three pairs of socks, three T-shirts, etc.). Clients can store excess clothing in a personal storage bin and switch out articles of clothing during their stay. ALL items in their bin will be returned to them upon discharge.

Visitation Hours and Rules

- > 200 (Gero): 10:00 AM – 6:00 PM
(one-hour increments; max 2 hours per day)
- > 300 (CD & Gero): 3:30 PM – 4:30 PM (on unit)
(CD clients allowed visitors 72-hours post-admission with treatment team approval)
- > 400 (Adult): 3:30 PM – 4:30 PM
- > 600/700 (Adol): 6:00-7:00 PM
- > 500 (Adult): 7:30-8:30 PM

Please arrive 10-20 minutes prior to the start of visitation to allow time for sign-in, restroom use, etc. Reception staff will not be able to transport visitors to/from restrooms during visitation. Visitors will be transported to/from the visitation area every 15 minutes during the hour. If visitors arrive within the last 20 minutes of visitation, they may not be permitted to visit. All visitors must sign in and will be required to produce an ID card at the time of visitation. The ID cards will be copied and added to the file. Applying this safety measure will better protect your loved ones' privacy. We thank you for your cooperation with this process!

All visitors must be listed on the client's visitor list. If you are not on the list, please contact the client's primary therapist. All visitors must be age 12 or older; please do not permit any children under 12 years of age to be left unattended in the lobby. Clients are allowed 2 visitors per night. Visitors are not permitted to switch-out during visitation unless prior arrangements have been made through the therapist. All visitors will go through a security check before attending visitation. Please make sure you have secured your belongings in a locker. Reception staff will provide a locker key to safely secure all belongings, such as:

- > Hats, bandanas, beanies
- > Coats, jackets, hoodies
- > Gloves, mittens, scarves
- > Wallets, purses, billfolds
- > Keys, key chains, lanyards
- > Chapstick, toiletries
- > ANY electronic devices (e.g., cell phones, iPods, MP3 players, etc.)
- > ANY outside food or drink, gum, candy, etc. (unless prior approval has been obtained in writing from a dietician or physician)
- > Water bottles, thermoses, coffee, etc.
- > Any large, bulky items

Service animals must have prior approval before being brought to the facility for visitation..
